Waukegan Township is proud to announce that from April of 2020 through February of 2021, we have successfully distributed over 8,000 safety kits to the residents of Waukegan Township! Over the past months, we know that COVID-19 has put a strain on personal protective equipment (PPE). We are also aware that the supply of PPE has improved since this spring, for which we are grateful. This has made it easier for Waukegan Township to continue working towards our goal of assisting in maintaining the safety of seniors throughout our community.

Many of our distributions included masks, gloves, hand sanitizer, fruit and lunch. We hope our approach; whether drive through, apartment complex distribution or home delivery, has helped each one of you. We thank our community partners and will continue providing these needed services for the months to come. We understand how important it is to supply these lifesaving items; if you find yourself in need of any (PPE) products, feel free to contact us as 847-244-9242. We will do our best to assist you in securing needed items.

We would also like to take this opportunity to thank our many partners for their assistance.

As development of and protocols for the vaccine distribution are still underway, we will continue to assist where we can, until we are out of this pandemic. Remember to stay home when possible, wear a mask, wash your hands, and stay six feet apart.

What we've been up to:

The staff at Park Place can't wait until we're able to open our doors and see each and every smiling face coming through. We have been closed since March 13, 2020, but have had periods when we have opened with limited participation in an effort to protect the safety and wellbeing of our seniors. Each closing was also due to a regulation mandated by the State of Illinois. Please know that the staff has been busy printing our monthly taxi-tickets, providing week day medical transportation to dialysis clients only, preparing our bi-monthly newsletter, processing Benefit Access applications, and assisting with Senior Health Insurance enrollment. I hope many of you have enjoyed the periodic wellbeing calls that have been made to all the seniors in our community. If you have not received one of our calls, please contact us at 847-244-9242 and have your information updated in our system. We would love to speak with you.

Park Place has also been busy sprucing up the place.

Class Details

Cardio and Crunches

Cardio and Crunches is an aerobic and abs class. No equipment needed. Can do exercises seated or standing.

Total Body Blast

Total Body Blast is a resistance training class. Should have a chair and 1 of the following: weights, two water bottles, two cans or a resistance band.

Serenity Stretch

Serenity Stretch is a stretch class for loosening tight muscles. A yoga strap, a long belt or a long towel would be helpful, especially if you're tight.

Chair Workout Warrior

Chair Workouts are great for those needing to sit for some of the exercises or hold on to a chair to exercise. You still will work out like a warrior! Should have weights and a resistance band, but not required.

Functional Fitness

Functional Fitness is a class that covers exercises that help with everyday movements such as bending down, squatting, reaching and lifting. Legs and shoulders are the primary focus of training. Should have weights, but not required.

Cardio Circuit Training

Cardio Circuit Training consists of doing 4-6 exercises from top to bottom and repeating them for several rounds in a row. About 2-3 circuits will be done each class.

Update From The Assessor's Office

The updated 2021 Equalization Factors are posted to the Lake County Government website. These include all sales through the month of November 2020. Please visit <https://www.lakecountyil.gov/389/Equalization-Factors>. Sales ratios have been updated. A final update to the equalization figures will post once the balance of the 2020 sales have been entered.

Please note that Lake County will not be subject to a State Equalization Factor this year.

- Veterans and spouses must call 1-800-827-1000, the VA Hotline/Chicago Regional Office (CRO) to obtain copies of their service connected disability letters either by fax or mail.
