## New addition



### Dressing the Abbey and High Tea at Pfister Hotel Wednesday May 18, 2022

Discover the Dressing the Abbey Exhibit of authentic costumes worn by the stars of Downton Abbey™ at the historic Charles Allis Mansion and Art Museum. The costumes on display were created for the show's aristocratic Crawley family on the hit series. Displays range from country tweeds and riding outfits; servants' uniforms and footmen's livery; to lavish evening attire crafted from sumptuous fabrics and decorated with intricate embroidery, lace and beading. After visiting Downton Abbey,™ we will enjoy High Tea at the magnificent Pfister Hotel. This experience will include tableside tea blending, presented in all-silver service by a Pfister Tea Butler, while learning about each variety of tea, the origins, unique flavors, effects on mood and health, blending options and perfect pairings. The afternoon tea menu is complete with fresh scones, sandwiches and pastries. Our fee of \$135 covers transportation, tour entry and dining expenses. ### Walk Back in Time in the Historic Pullman District Tuesday, May 24, 2022

Ride Lake County offers residents a unique way to get around Lake County. Whether you need a ride for work, medical and dialysis appointments, or shopping, Ride Lake County offers an easy to use travel experience that is both affordable and flexible.

As a dial-a-ride program, Ride Lake County service is on demand, and buses do not travel in a fixed route each day. Instead, riders schedule their trips in advance and the Ride Lake County vehicle provides curb-to-curb service from the rider's desired pick up and drop off locations.

The program is a shared-ride service, so the vehicle may make additional stops during your trip to pick up other passengers. To accommodate multiple riders and provide as many trips as possible, the route taken by the vehicle is planned well in advance for efficiency purposes.

# What You Should Know

## New Update from Social Security



The local Social Security offices has restored in-person services, including walk-ins.

To avoid waiting in line, we strongly encourage people who can, to use our online services at [www.socialsecurity.gov](http://www.socialsecurity.gov), call us and schedule appointments in advance rather than walking in without an appointment. Phone appointments can save you a trip to a busy office. We thank the public for your patience as we work to increase service.

Customers who walk in without appointments may encounter delays and longer waits at our offices. Be aware that our offices tend to be the busiest first thing in the morning, early in the week, and during the early part of the month, so people may want to plan to visit at other times.

Given that many of the people we serve have health vulnerabilities, and consistent with our union agreements, we are continuing to require certain safety measures including masking, physical distancing and self-health checks for COVID-19 symptoms. We will provide masks to the public and employees if they need them.

Thoughtful planning and preparation have shaped our process to restore in-person services. Social Security employees are dedicated to serving the public, and we are ready to welcome the public back to our offices. Our local managers understand and can address the needs of their communities. We have also implemented office-to-office support as well as brought recently retired employees back to assist the public. We thank the many interested stakeholders including the Department of Health and Human Services' Administration for Community Living and national advocate organizations for your help.

Throughout the pandemic, millions of people have used our secure and convenient online services and received help by phone. People who have access to the internet should first try our online services before calling us or visiting an office.

As we transition to a new modern phone system, some callers may experience a busy signal or be unintentionally disconnected from their call. We sincerely regret this disruption and recommend people call when our National 800 number may be less busy, such as before 10 a.m. or after 4 p.m. local time or later in the week. As with our offices, our waiting time is shorter later in the month.
