TINY MIRACLES

There are less than a handful of jobs those with sex offenses qualify for in prison: janitor and kitchen work. All the good jobs I'd like, tutor, law library, general library, teacher's asst. etc., are beyond my reach...and it's beyond frustrating. I do what I can: I pray, I network, I even wrote letters to the Warden, Director of the Dept. of Prisons and Governor; but the answer is always the same: "According to department regulations you do not qualify." Then COVID hit and all the rules went out the window.

Inmates were dropping like flies, getting sick, being sent to the hospital, even dying -- the prison could no longer be so picky about who deserved what job if they wanted to keep the prison running (FYI-inmates essentially run the prison, the officers are "supervisors"). And so it came to pass that I started working as a essential worker in the prison's quarantine hospital wing.

A job few others wanted and was especially physically and emotionally taxing. I spent 8-12 hours in full PPE, sweating pounds of water weight daily, transporting and caring for sick COVID positive inmates all over the prison facility. It was a gut wrenching experience as I literally carried one friend's limp dead body to a waiting ambulance and then watched another take his last breath while sitting on his cot in his cell...waiting for medical attention that would not arrive in time. Eventually, we would peak and reach herd immunity. They no longer needed me.

How did you change your life for the better?

The Coalition group were tremendously helpful in assisting me with any questions or concerns in regards to my felony and they were able to help me felony conviction sealed.

HB 1064: Abolish Life Without Parole For Children And Emerging Adults

HB 1064 would prevent life without parole sentences for most people 20 and younger. It creates an opportunity for people younger than 21 when convicted and sentenced to first-degree murder or a term of natural life imprisonment to be eligible for parole review. People could petition the Prisoner Review Board for parole consideration after serving 40 years or more of their sentences.

Why We Need to Abolish Juvenile Life Without Parole Sentences in Illinois:

When imposing a sentence of life without parole (LWOP), a judge decides a child is beyond rehabilitation. Consider the following.

- **SCIENCE:** Both scientific and actuarial studies have proven the brain continues developing until a person is around 25 years old.
- **SCOTUS:** The US Supreme Court has repeatedly emphasized children are “categorically less culpable” than adults and are **more capable of rehabilitation**.
- **ILLINOIS COURTS:** Illinois courts have affirmed SCOTUS and now face the difficult task of untangling decades of excessive sentencing.
- We have found **no research that demonstrates juvenile life without parole sentences (JLWOP) have a deterrent effect on crime**.
- **INTERNATIONAL LAW:** The practice of sentencing children to LWOP violates Article 37 of the Convention on the Rights of the Child (CRC).
- Research shows a **recidivism rate of just 1.14%** among people sentenced to JLWOP and then subsequently released.

Solution:

We can build on recent legislative progress in Illinois to align our state with science, court decisions, and international standards. This bill would prohibit LWOP sentences for most youth who were under the age of 21 when their crimes were committed. **Juveniles could still serve life in prison.** This bill simply ensures they have a limited opportunity to be considered for parole. **The legislation would not be retroactive.** Here's what it would do:

- Most youth given long terms of incarceration would have the opportunity to go before the Prisoner Review Board after 10 years and would then be allowed to seek parole two more times—unless they've been convicted of one of a handful of crimes (exceptions outlined below).
- Youth convicted of predatory criminal sexual assault of a child would not be eligible for parole under this bill.
- Youth convicted of aggravated criminal sexual assault and most forms of first-degree murder would be eligible for parole after 20 years, and once more after another 10 years.
- Youth with life sentences would be eligible for review after 40 years.

The Youthful Parole Bill, HB 531, now Public Act 100-1182, is one of the most significant accomplishments of the General Assembly and Governor's Office. HB 1064 is a natural progression to ensure no children are sentenced to life without the possibility of parole.

Throughout 2021, the Coalition to Reduce Recidivism sought to bring awareness to the needs of women after incarceration. When a woman is incarcerated it not only affects her as an individual, but the entire family unit as well as the community in which she resides. Our goal was to provide a sense of empowerment and a source of encouragement and to let women know that support is readily available. As issues are addressed, healing takes place and communities are strengthened. By presenting our series of Virtual Women's Round Table events, designed to not only bring awareness to the plight women face, but offer solutions, through peer-to-peer discussions - we were able to do just that.

February 2021: our inaugural event, featuring Dr. Michelle Vaughn, our dynamic keynote speaker; along with moderator, Dr. Mary Roberson (Executive Director, NIRCO) and four panelists. Each woman on the panel, Denise Acevedo, Tina Arnold, Johnnie Jenkins and Carrie Panos allowed us to peer inside of aspects of their personal journey before, during and after incarceration. Each story was uniquely powerful, leaving the audience speechless and yearning to understand each individual story.

May 2021: the second Virtual Women's Round Table, moderated by Coalition Board President, Dr. Mary Roberson, coincided with Mother's Day weekend. A focused discussion on Adult-Children Relationships of women after incarceration, with the staggering and heart-breaking statistics regarding the children of incarcerated mothers. The Coalition received the support of the Lake County Sheriff's Office, and as a special treat, each detainee was the recipient of a handmade Mother's Day card, created by the fifth-grade students at Waukegan's Clearview Elementary School. The women were also gifted with copies of the book, ***"A Knock at Midnight: A Story of Hope Justice, and Freedom"*** written by Brittney K. Barnett, Esq., one of the event panelists. The remaining panelists, mother and daughter groups Ms. Celia Colon and daughter Amanda Avila; Ms. Evelyn Fulbright (mother of Brittany K. Barnett) and Elizabeth Taylor and her daughter Angie Gustosson. Our Keynote speaker, Ms. Tiffiney Ross, Minister and Funding Development Coordinator for R.I.S.E. Re-entry Prison Ministries, shared her

experience of being incarcerated and pregnant, as well as how her environment impacted her choices.

September 2021: was the third segment of Virtual Women's Round Table series with its emphasis on the unspoken yet pressing issue of Domestic Violence. Ms. Rebecca Weinger, North Suburban Legal Aid Clinic shared with the audience in very discrete, non-descriptive ways of how women are aided. "Domestic violence is not always obvious and takes on several forms and methods". Our panelists, Takesha Newsome Tyra Randle, Tara Evans, Chantel Marie and our dynamic keynote speaker, Willette Benford of Live Free Illinois, participated as and shared candidly their respective journeys of domestic violence survival and, in the case of Ms. Bedford, being incarcerated for over 2 decades. Willette has turned her pain into power and speaks up for the needs of women currently imprisoned. "A person who asks the question why she doesn't just leave, really does not understand what a woman goes through while living this horrible experience".

This is one example of why Coalition Legal's mission is so important: Client JM has had a clean record for 30 years. He has not been arrested since 1992, however, he just lost a good job because in 1992 he was convicted of theft. He was given probation rather than jail time. He paid his fine and his probation terminated satisfactorily. Yet, 30 years later, that one case was used by a prospective employer to deny JM a job.

Not everyone has this trouble. We understand that many local employers are overlooking criminal backgrounds because they need the help – now! But that job may be temporary and when the current tight labor market loosens up, it too, may disappear.

For many reasons, this is the perfect time to get your criminal record expunged or sealed. If you are looking for a job, you can respond “no” to the question of “have you ever been convicted of a crime?” If you have a job, your job will help a judge decide that you are a good candidate to have your records expunged or sealed.

We have worked with almost 500 people in the past five years. Most of them live in Lake County, however, we have had clients from Texas, Florida, California, Georgia and Indiana, all of whom can appear in court remotely, via Zoom, as easily as if they lived in Waukegan. We do not charge for our legal services and if you qualify for a fee waiver, we can file petitions at no cost to you. If you need a drug test because of a drug conviction, we can obtain a drug test for you at no cost. Please go to our website at www.coalitionlegal.org to sign up for services.

Non-convictions (nolle pros, successful supervisions, acquittals) are expungable. Convictions (fines, probation, jail/prison) can be sealed, but not expunged.

Coalition Legal Services:

- Coalition Legal helps people expunge or seal eligible criminal records as authorized by Illinois law. We also assist with Clemency Filings to the Governor.
- Collaboration with Waukegan Township for workforce referrals and job placement.
- FBI Background checks and fingerprinting services.

[Fingerprinting services are provided at the Supervisor's Office](#), located at 149 S. Genesee Street, Waukegan, IL. Individuals needing fingerprint records for the expungement or sealing process would need to first begin the initial sealing process and the attorney will arrange for them to come for fingerprints if needed. There is a fee of \$18 for these services.

C2RR Virtual Fundraiser

Although society is now, for the most part, “re-opened” it was not yet the case on October 8, 2021, when we held our second virtual fundraising event. 2021’s fundraiser was one of our highest attended (virtual) events with participants spanning all sectors of society. First Lady of Illinois, MK Pritzker opened with an outstanding welcome address, sharing her passion for incarcerated women and their families. Several Elected Officials graced our virtual stage: U.S. Congressman Brad Schneider, Lake County Sheriff John Idleburg, Mayor Nancy Rotering (Highland Park) all shared their perspectives based on our theme, “**Ripples of Hope**”

derived from a quote by the late Robert F. Kennedy: “**Each time a man stands up for an ideal or acts to improve the lot of others or strikes out against injustice, he sends forth a tiny ripple of hope.**”

Miss USA 2020, Asya Branch, shared how her family dynamic was affected by her father’s 10 + years of incarceration. Our guest speaker Yaakov Delaney, Director of Justice & Fairness, Lieutenant for Lt. Governor Stratton’s Office, shared a portion of his journey after over seventeen years in the Illinois Department of Corrections. The highlight of the entire program was Dr. Reuben Miller, University of Chicago Professor, Sociologist and Chaplin for Cook County jail, as he shared his incredible experiences along with alarming data, on the disproportionate number of people of color that are detained, simply because of the zip code where they reside. His book, “**Halfway Home: Race, Punishment, and the Afterlife of Mass Incarceration**” will forever change the way we look at life after prison in America. The 19th Annual Coalition Fundraiser Event will take place on October 7, 2022, more details to come.



I heard about a newly created "clerk" role running the warehouse/general store. In prison, "clerks" are the top of the food chain; another way of saying manager. There are only 3 clerk roles that essentially run all the departments. Although I knew what the answer would be, I sent in my application and request slip. You can imagine my surprise when I received a notice that I had been submitted for a vote sheet. A vote sheet is where the dept. heads vote on whether they approve of you in the role: they check your job history, disciplinary background; your case and sentencing, etc.

I was sure I would be denied, but was thrilled to even be considered. I saw this as progress. This particular role was especially unique as it was technically off-grounds, on the outside of the inner perimeter fence - only a VERY select few qualify for "outside clearance" and I had way too much time left before I would ever even be considered. So, I didn't even give it a second thought.

And then lightning struck, the stars aligned, and God smiled on His humble son. I got the job! During the height of our virus outbreak, when we were averaging up to 200 positive cases a day and everyone else was locked down. I was crisscrossing the prison in my white gown, blue gloves and footies, face shield and hair net moving inmates (and all their belongings) from one building to another. From their housing building to the quarantine building, then sometimes to the hospital building, and then eventually back to their housing units (the lucky ones anyway). I worked 7 days a week, double shifts, often forgetting to eat as I was overwhelmed with work. The prison was literally a ghost town, except for yours truly hoofing it to and fro. It seems the officers, warden, and even a visiting State Rep. noticed that one random guy working his tail off without complaint and they remembered my name when the time came to vote. Once unbreakable rules, they had made an exception.
