

WAUKEGAN TOWNSHIP ROAD DISTRICT
TAX LEVY ORDINANCE NO. 22-04

An ordinance levying taxes for all road purposes for Waukegan Township Road District, Lake County, Illinois, for the tax year 2022 collectable in 2023

BE IT ORDAINED, by the Board of Trustees of Waukegan Township, Lake County, Illinois, as follows:

SECTION 1: That the Township Supervisor of Waukegan Township on December 8, 2022, does hereby determine and declare that the sum of Two Hundred Hundred Eighty Six Thousand Nine Hundred Thirty Eight and 00/100 Dollars (\$286,938.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law for such purposes as:



SECTION 3: That the Town Clerk shall file with the County Clerk of said County of Lake, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied necessary to be raised by taxation for road purposes for Waukegan Township Road District.


